Article 2:

It shall be the prerogative of the Bar Secretary to organize and assign duties to the Deputy Secretaries.

Regional and Divisional Representatives as well as Special Delegates of the Bar President, are hereby vested with the powers of the Bar President, except for fees or honorarium disputes where the amount is more than fifty millions or where such disputes involve public or State Institutions.

Article 3:

Regional and Divisional Representatives as well as Special Delegates, are each required to provide a quarterly report of their activities to the Bar President.

Article 4:

At the behest of the Bar Secretary, this Decision shall be notified on the concerned and published accordingly.
