**DECISION N°014/BOA/01/2023**  
**APPOINTING MEMBERS TO THE BAR-ROLL COMMISSION**  
**OF THE CAMEROON BAR ASSOCIATION**

**THE PRESIDENT OF THE CAMEROON BAR ASSOCIATION,**

MINDFUL of Law No. 90/059 of the 19th of December, 1990 to organize Practice at the Bar;

MINDFUL of Decision N°41/DPJ/SG/MJ of 12 April 2005 on the Internal Regulations of the Cameroon Bar Association;
