**DECISION N°015/BOA/01/2023  
APPOINTING MEMBERS TO THE PROTOCOL AND

THE CAMEROON BAR ASSOCIATION**

**THE PRESIDENT OF THE CAMEROON BAR ASSOCIATION,**

MINDFUL of Law No. 90/059 of 19th December 1990 to organize Practice at the Bar;

MINDFUL of Decision N°41/DPJ/SG/MJ of 12th April 2005 on the Internal Regulations of the Cameroon Bar Association;
